Employment Contract of Foreign Domestic Worker (FDW)

This employment contract is made between Employer and Foreign Domestic Worker and be effective after the FDW commencement date mentioned in the contract period under the following terms and conditions

Employer: **Nahid Ahmed**, 8A Upper Boon Keng Road #19-518, Singapore 381008(NRIC No. S6980237J)

Foreign Domestic Worker: **ALO BAROI**, Nationality: Bangladeshi, Passport number – A08014804.

Terms & Conditions of Employment:

- Contract period of two years from start of work in Singapore. After successful completion of 2 years, contract may be extended upon mutual agreement by both parties.
- Travel, all employment related expenses in Bangladesh & Singapore will be borne by the Employer. If the FDW fails to pass the entry in Singapore, she would be repatriated to Bangladesh at Employers cost.
- Monthly salary payable in Singapore Dollar of s\$350 per month. Salary will be payable via cash/bank account. Employer will maintain a written acknowledgement of all salary payment, remittance, and other expenses of the FDW
- To do al household duties: -cleaning full house, washing and ironing of clothes and cooking etc. in the home address of Employer. Number of rest days per month - 4, though the Employee may work on rest days as mutually agreed by Employee and Employer.
- Compensation in lieu of Rest days - appx s\$13.46/rest day. This is based on the MOM calculation.
- Employer will provide all free food & lodging, clothing, and personal items such as soap' shampoo and toothpaste etc.
- Employer to cover FDW under Medical insurance (In-patient care & day surgery) & personal Accident insurance according to Singapore "In-Principal Approval (IPA)" from Ministry of Manpower (MOM).
- Termination of Contract: Employer to give one month of notice at any time. No notice is required in the cases of misconduct by the FDW or threat by employer.
- Singapore Government levy & other expenses will be borne by the employer.
- Dispute settlement: Employer and worker should first try to resolve any dispute by themselves, failing which, the assistance of the other or the Singapore MOM may be sought.
- On early termination of the contract no further salary shall be owed to or paid to the Employee. Partial month's pay will be prorated.
- The contract will be governed by the laws of Singapore. The Employee is responsible for being compliant with all legal obligations.

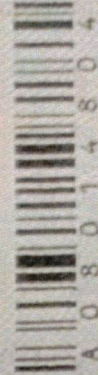

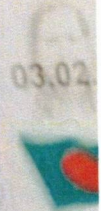
