The Government of the People's Republic of Bangladesh has received for the loans from Japan International Cooperation Agency (JICA) towards the cost of the Dhaka Mass Rapid Transit Development Project (Line-1) and intends to apply part of the proceeds towards payment under the Contract for Signal System, Telecommunication System, Platform Screen Doors and Enterprise Resource Management System resulting from the bidding for which this prequalification is being conducted.
2. Dhaka Mass Rapid Transit Development Project (Line-1) will construct 30.179 kilometer (17.864 km underground and 12.315 km elevated) metro rail system with 12 underground stations and 7 viaduct stations and one maintenance depot at grade. The Dhaka Mass Transit Company Limited (DMTCL) (hereinafter referred to as "the Employer") now intends to prequalify firms for the following plants to be procured:
 - (1) Signaling System,
 - (2) Telecommunications Systems,
 - (3) Enterprise Resource Management System, and
 - (4) Platform Screen Doors (PSD).


Plant requirements are envisaged in Sub-Clause 1.2 [Outline of Works in CP10 Package] of Section VI.

3. It is expected that Invitation for Bids will be made in January 2023.
4. Prequalification will be conducted through procedures in accordance with the applicable Guidelines for Procurement under Japanese ODA Loans, and is open to all Applicants from
